RecycleKits' safety containers meet your specific needs for:

- A. Fluorescent, mercury vapor, metal halide, ultra-violet double, and high-pressure sodium lamps:** 4', 6' or 8' reinforced boxes with 4-mil protective liner.
- B. Batteries and Non-PCB ballasts:** One-gal. (12-lb.) or five-gal. (60-lb.) heavy-duty DOT-approved pail.
- C. Mercury:** One-gal. Mercury Spill Kit for clean up of mercury. One-gal. and five-gal. heavy-duty DOT-approved pails for mercury containing devices.
- D. Electronic equipment:** 24" x 24" reinforced box holds up to 60-lb. of electronics. One-gal. DOT-approved pail, holds approx. 50 cell phones.
